c. Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

**Important Note:**

- 1) **The Continuation / Extension of Affiliation is issued for the Academic Year 2020-2021 subject to the permission of Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1<sup>st</sup> year of the course until receipt of permission of the Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.**
- 2) **The admission shall be done only through the Competent Authorities.**
