As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, as per NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 Performa were examined by the Medical Assessment and Rating Board.

2. On careful examination of the report the remarks regarding of staff, infrastructure, equipment and instruments and other facilities available in the Vasantrao Kale Homoeopathic Medical College & Hospital, P-12, MIDC, Kallam Road, Latur, Maharashtra 413531 and homoeopathic hospital, it is observed that college fulfill all requirements as per prevailing regulations.


The college is directed to fulfill all shortfalls within a period of 1 month and compliance report shall be submitted to the board. The college is also directed to submit the certificate of continuation of affiliation for the previous year along with the compliance.

After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is granted to the **Vasantrao Kale Homoeopathic Medical College & Hospital, P-12, MIDC, Kallam Road, Latur, Maharashtra 413531 for conducting UG (BHMS) course with intake capacity of 75 seats for the academic year 2022-23.**

3. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under.

4. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules. The College has to comply with the full requirements as per NCH Act, 2020 for conducting the course.
